"And indeed, you are of a great moral character!"


This verse highlights the exemplary character and manners of the Prophet Muhammad [2].

For example, Abdullah ibn Mas'ud asked the Prophet Muhammad:

"What deed is most beloved to Allah?" The Prophet Muhammad replied: "Performing prayer on time." Abdullah then asked: "What comes next?" The Prophet said:

"Being good to your parents." This hadith emphasizes the great importance Islam places on respecting parents [3].

### The Condemnation of Lying

Lying is one of the most severely condemned sins in Islam. Prophet Muhammad said:

"The liar is not of my followers."

Lying can bring numerous calamities upon individuals and society. It is listed among the gravest sins, alongside associating partners with Allah (shirk).

### Slander and its Consequences

Anas ibn Malik narrated that the Prophet Muhammad once said:

"The greatest sins are: associating partners with Allah, committing suicide, and disobedience to parents. And among the gravest sins is false testimony." [6]

This hadith underscores the seriousness of slander and false testimony, which are considered major sins in Islam.
