In this regard, a number of measures are being implemented to ensure the rule of law, protect the rights and freedoms of citizens, reform the judicial system, and fight corruption.

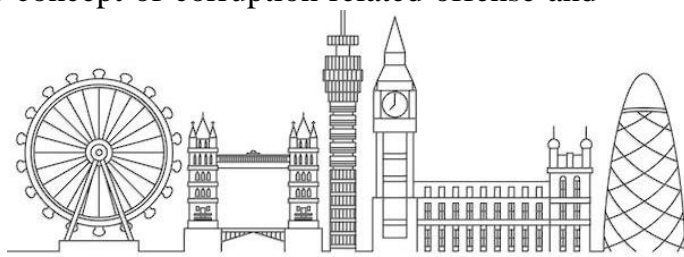
Currently, the disease of "Corruption" is resisting the stable development of every developed and developing country. That is why the fight against corruption remains an urgent problem for countries all over the world. The term "corruption" is derived from the Latin word "corruptio", which etymologically means "to spoil, buy". That is, corruption is a socially dangerous phenomenon in the field of politics and state administration, the illegal use of their status and related opportunities to obtain material and other wealth and privileges by persons who have the authority to perform state functions or are equal to them, and also use these wealth and privileges physically or is to allow legal entities to take possession illegally. It is well known from the experience of some countries in the world that corruption and bribery destroy the state from the inside. Creates social inequality in society;

- It destroys the confidence of the population and the people in the ongoing reforms;
- Creates injustice in existing social relations in the society;
- At worst, it can cause various protests among the population.

According to economist Berdchen, corruption is the factor that brings the biggest negative wave to the indicator of macroeconomic development. Its appearance can be different. Hundreds and thousands of studies have been conducted by specialists, various institutes and international organizations to determine the causes of its origin, to find effective ways to fight against corruption. Specific ratings were created and tables were created with various indicators and numbers. Even formulas of various forms of corruption have been developed. So far, there is no one-size-fits-all solution to fighting back that works for all nations.

On January 3, 2017, the Law of the Republic of Uzbekistan "On Combating Corruption" was adopted, creating a legal mechanism for combating corruption. Its main purpose is to regulate relations in the field of combating corruption.

Article 3 of the Law of the Republic of Uzbekistan "On Combating Corruption" provides the basic concepts, which defines the concept of corruption related offense and

conflict of interest, i.e. corruption - the personal interests of a person from his position or official position, or the interests of other persons. unlawfully using such a name for material or immaterial gain, as well as illegal is to present it. Honorable President Shavkat Miromonovich Mirziyoyev in his speech at the joint session of the Oliy Majlis of the Republic of Uzbekistan on the topic "We will build a free and prosperous, democratic state of Uzbekistan together with our brave and noble people" said: "To fight against and prevent corruption, various crimes and other violations in our society, to ensure in practice the requirements of the law that punishment for crime is inevitable it is necessary to take strict measures", he emphasized not without reason. As the First President of the Republic of Uzbekistan, Islam Karimov, noted, "The level of legal culture is not only knowledge of laws, awareness of legal information. It means the culture of following and obeying the laws. It means the need to respect the justice court, to apply to the court to protect one's rights. Legal culture means refusal to use illegal forces in solving various conflicts. In fact, raising the legal consciousness and legal culture of the population in the fight against corruption, forming an intolerant attitude towards corruption in the society, increasing the legal literacy of the employees of state bodies and other organizations, legal education and training in the field of fighting corruption in educational institutions, 16, 17, It is expressed in Articles 18. Because people with high legal consciousness and legal culture and mature in terms of legal education and upbringing do not allow corruption, which is a negative vice.

In connection with the improvement of the anti-corruption system of the Republic of Uzbekistan, the Law on Amendments and Additions to Certain Legislation of the Republic of Uzbekistan (O'RQ-729, 18.11.2021) was signed by the President. According to the additions, it was determined that the employees of the Anti-Corruption Agency have the right to unimpeded access to the penal institutions and documents to study and analyze the commission of corruption offenses.

The anti-corruption agency annually submits a national report on the fight against corruption to the Oliy Majlis.

Of the persons who provide information about corruption offenses will also be under state protection (previously, only the persons who informed are provided). Our opinion is evidenced by the fact that Uzbekistan has increased by 7 points in 2020 compared to 2019, and by 6 points in 2021 in the "Acceptance of Corruption" index of the "Transparency International" organization, and has achieved stable growth in the index value for 5 years in a row. In our country, the work in this regard is continued continuously. In order to achieve higher results in this regard, it is advisable to increase the knowledge of citizens and officials on fighting corruption electronically, and to use the opportunities of mass media, civil society institutions and non-governmental organizations more in forming an uncompromising attitude against corruption in society.

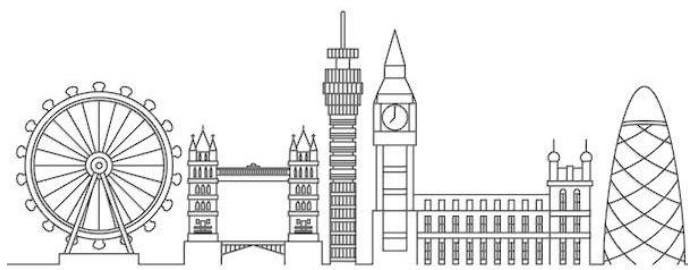

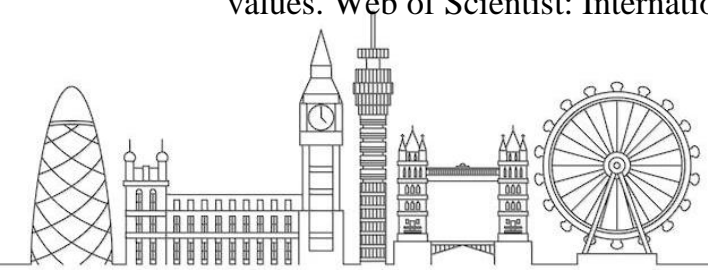
